Minutes of June 1, 2015 Special Council Meeting

The Public Hearing for the proposed Minor Variances was called to order. The purpose and effect of the requested minor variances is to construct a single detached dwelling including an attached deck and a detached garage. The reductions requested are as follows:

- 1. To reduce the front yard setback from 65.6' to 41' to deck/53' to house;
- 2. To reduce the rear yard setback from 32.8' to 20' for dwelling;
- 3. To reduce the front yard setback from 65.6' to 40' for detached garage.

The applicant, Patricia Husak, and Bob Husak attended the public hearing. No other person attended the public hearing or was represented and no written submissions were received related to the proposed minor variances.

- 5. Section 5.25.3 of the Comprehensive Zoning By-law to allow the detached garage to be constructed in a front yard.
